

# **KA SCHEME AI JINGKYRSHAN PISA BAN PYNNEH PYNSAH IA KA MARIANG NE PAYMENT FOR ECOSYSTEM (PES) SCHEME**

## **KI JINGKYLLO BA JU KYLLI MAN KA POR**

- 1) Hato kino kino ki jait khlaw ki lah ban ioh jingiarap hapoh jong kane ka scheme?**  
Em. Tang kito ki khlaw kibym lah ban pyndonkam kum ki lad kamai ne ki Natural Forest ki lah ban ioh ia kane ka scheme. Natural Forest ka mut kito ki khlaw ki bym don kino kino ki jingthung ba lah ban pynlong lad kamai ne kiba don tang shijait ki dieng (kum ki dieng kwai, dieng kseh, dieng sal, dieng cashew, dieng coffee, dieng jri bad kiwei kiwei).
- 2) Nga/ngi don ka jaka kaba heh kiba hap hapoh ka Natural Forest bad nga/ngi kwah ban ioh bynta ia kane ka PES scheme hynrei ngim tip katno ka jingheh jong ka jaka. Kumno nga/ngin leh?**  
Lada phim tip ia ka jingheh jong ka jaka ba don ia ka Natural Forest kaba phi thmu ban buh ka jingtyrwa na ka bynta kane, phi lah ban iaid sha khmat bad apply ia ka PES scheme. Phi lah ban shu iathuh antad ia ka jingheh jong ka khlaw ha kane ka phom. Hadien ngin sap hah ia ka kynhun da ka Meghalaya Basin Management Agency (MBMA) ban leit peit bad thew ia ka jaka.
- 3) Ha khlaw Jong nga don ka lum jingtip ne ka jaka kyntang ban leh niam. Hato dang long?**  
Hooid dang long katba ka dang don ka khlaw ne natural forest.
- 4) Da kaba iashim bynta ha kane ka progkram, hato nga/ngin duh ia ka jingling trai ia kane ka khlaw?**  
Em. Kan ym don ka jingkylla ha ka jingling trai ia ka khlaw.
- 5) Ha ki kyndon ba la buh la ong ba yn pynneh pynsah ia ki khlaw ym duna ia ka 30 snem khnang ban ioh ia kane ka scheme. Hato ngin ioh ia ka jingkyrshan pisa man la u snem haduh 30 snem?**  
Em, ka jingkyrshan pisa kan long na ka bynta 5 snem. Hynrei na ka bynta ba phin ioh ia ka jingkyrshan hapoh jong ka PES scheme, phi dei ban rai ban iada ia ka khlaw ym duna ia ka 30 snem..
- 6) Kaei kaban jia hadien 5 snem ynda la kut ka PES scheme?**  
Na ka bynta kito ki trai jaka bad kito kiba pyndonkam ia ka khlaw kiba lah shisha ban iada ia ka khlaw jong ki, ka sorkar hapoh jong ka PES scheme kan iarap ban pyniasoh bad kiwei kiwei ki shnat kiba napoh ri lajong bad shabar ri khnang ba ka jingkyrshan pisa kan iai bteng wat hadien habud.
- 7) Nga /ngi dei /ki trai jong kane ka khlaw. Hynrei, kidon ki longing na shnong kiba pyndonkam ia kane ka khlaw na ka bynta ka jingdonkam jong ki ba man la ka sngi. Hato ka jingmyntoi lyngba ka PES tang jong nga marawei/tang jong ngi?**  
Em.  
Ka PES scheme ka thmu ban pynduna ia ka jingshaniah jong ki biew ha ki natural forest khnang ba ki lah ban pynneh pynsah bun snem haduh hadien habuh ruh. Lada ki jingioh nong ym shym la iasam leh ban kito kiba shaniah na kane ka khlaw na ka bynta ka jingim jong ki ba man la ka sngi,

kumta kim don da kiwei pat ki lad hynrei bad dang iai pyndonkam hi ia kane ka khlaw. Kane kan sa wanrah jingeh ban pynneh ia ka, bad kumta kan sa ialam sha ka jingshah kyntait noh jong phi na kane ka PES scheme. **Hynrei, lada ym don mano mano ba pyndonkam ia kane ka khlaw, ka jingmyntoi baroh kan leit sha phi.** Ia ka jingioh myntoi lah ban iasam katkum ba la batai ha ka jingkylli kaba 9 harum.

- 8) **Nga dei I Nokma bad nga don ia ka khlaw hynrei nga la ai ki nongshnong shnong ban pyndonkam ia ka na ka bynta ki jingdonkam jong ki ba man la ka sngi. Hato ka jingioh myntoi na kane ka jingkyrshan pisa kan long tang jong nga marwei ne nga hap ban iasam bad ki nongshnong shnong?**

Ia ka jingioh myntoi dei ban iasam bad baroh kito kiba pyndonkam ia ka khlaw. Kumba la batai ha ki jingkylli ba ha khmat, lada ia ki jingmyntoi ym shym la iasam lang hapdeng kito kiba pyndonkam ia ka khlaw na ka bynta ka jingim ba man la ka sngi, kumta kin iai pyndonkam ia kane ka khlaw bad kan sa wanrah jingeh ban pynneh pynsah ia ka khlaw bad ka lah ban ialam ruh sha ka jingshah kyntait ban ioh ia kane ka scheme. Ia ka jingmyntoi dei ban iasam bad kito baroh kiba pyndonkam ne kiba shaniah na kane ka khlaw kumba la batai ha ka jingkylli ba 9 harum.

- 9) **Ka Hima/Raid bad ka khlaw kadei hapoh ka jingpyniaid jong nga. Hynrei kidon ki longing ha shnong kiba don hajan jong kane ka khlaw kiba pyndonkam ia ka khlaw na ka bynta ki jingdon jong ngi ba man la ka sngi. Hato nga donkam ban iasam ia ka jingioh myntoi na ka PES ba kito kiba pyndonkam?**

Hood,, hap ban iasam ia ki jingmyntoi bad kito baroh kiba pyndonkam ia kane ka khlaw. Kumba la batai ha ka jingkylli ba 6, lada ia ka jingmyntoi ym shym la sam bad kito kiba pyndonkam ia kane ka khlaw ba kin im ka jingim man ka sngi, ngin sa hap ban iai bteng ban pyndonkam ia kane ka khlaw bad kan wanrah jingeh ban pynneh pynsah ia ka te kumta ka lah ban ialam sha ka jingshah kyntait ban ioh ia kane ka scheme. Ka jingmyntoi ba ioh dei ban iasam lnag bad kito kiba pyndonkam ne shaniah ha kane ka khlaw kumba la batai ha ka jingkylli ba 6 haneng.

- 10) **Katno ka bhah ba hap ban iasam hapdeng I trai bad kiba pyndonka ia kane ka khlaw na ka jingkyrshan pisa ba la ioh?**

Shi bynta na ka jingkyrshan pisa ba la ioh lyngba ka PES ka long ban leh ia ki kam bapher bapher kumba la kdew ha ki kyndon treikam. Hynrei ka pisa kaba dang sah, I trai jaka bad kito kiba pyndonkam ia ka jaka ki lah ban iashong lang ban pyrkhat kumno ban ia sam ia kane ka jingioh myntoi hapdeng jong ki.

I. Lada ka khlaw kadei ka nongkynti jong ka shnong ne ki kynhun shnong ne kur

- a. Kumba la kdew ha ki kyndon ba iadei bad kane ka scheme, na ka bynta ki khlaw ba long trai da ka shnong, ki kynhun shnong ne ka kur, na ka bynta 50 hektar phin ioh. 8,000 tyngka shi snem. Shuh shuh san a ka bynta 50 hektar kaba bud phin ioh 50 na ka shispah na katie ka pisa, kaba mut phin ioh. 4,000 tyngka shi hektar shi snem. Na ka bynta kiwei pat ki jaka ba dang sah, phin ioh 25 na ka shispah na ka pisa ba la mang kaba mut 2000 tyngka shi hektar shi snem. Kumta na ka bynt 250 hektar ka jingheh ka jaka, ka pisa kaba phi dei ban ioh ha ka shisnem ka long kumne harum:

50 hektare x Rs.8,000 = Rs. 4,00,000/- tyngka

50 hectare x Rs.4,000 = Rs. 2,00,000/- tyngka

150 hectare x Rs. 2,000 = Rs. 3,00,000/- tyngka

Ka pisa baroh: 250 hektar = Rs. 9,00,000/- tyngka

- b. 50 hektar x Rs.2,500 = Rs. 1,25,000/- tyngka

150 hektar x Rs. 1,660 = Rs. 2,49,000/- tyngka

Ka pisa baroh: 250 hektar = Rs. 6,24,000/- tyngka

- c. Na ka bynta ki 250 hektar, ka jingioh nong ha ka shi snem kan long kumne harum:

50 hektar x Rs.2,000 = Rs. 1,00,000/- tyngka

50 hektare x Rs.1,000 = Rs. 50,000/- tyngka

150 hektar x Rs. 500 = Rs. 75,000/- tyngka

Ka pisa baroh: 250 hektare = Rs. 2,25,000/- tyngka

Kumta lada ioh ia kane, ka pisa kaba phi lah ban ioh na ka bynta 250 hektar jong ka khlaw kan long **Rs.9,00,000/- tyngka shi snem** kata ruh kaba rit eh bad ka lah ban poi haduh **Rs.17,49,000/- shi snem.**

**21) Hato don kano kano ka jingpyn shitom lada nga/ngi pynkhein ia ki jingiateh kular ban pynneh pynsah ia ki khlaw hapoh kane ka scheme?**
